Consórcio de Cooperativismo de Plataforma (PCC)

O Platform Cooperativism Consortium (PCC) é um grupo de pesquisadores e ativistas de todo o mundo que têm buscado construir uma economia digital mais democrática, justa e descentralizada para trabalhadores e comunidades. Nós fazemos isso incentivando o uso de princípios cooperativos no trabalho de plataforma e na infraestrutura da internet. Esses princípios são: adesão livre e voluntária; participação gestão democrática; econômica; autonomia e independência; educação, formação e informação; intercooperação; e interesse pela comunidade. O consórcio é um hub que apoia grupos que iniciam, crescem e se convertem em cooperativas de plataforma. Fazemos isso por meio da criação de análises de políticas, recursos como nosso diretório

e extensa biblioteca, pesquisas (por exemplo, nossos relatórios de bolsas), construção de comunidades (conferências e programação anuais), cursos, consultoria e coordenação global. Nosso objetivo é criar um ecossistema em que as cooperativas de plataforma possam prosperar. Trabalhamos com startups, cooperativas já existentes, acadêmicos, formuladores de políticas, financiadores e aliados em outros movimentos para construir uma coalizão para a mudança do sistema. Os membros do PCC estão trabalhando juntos para elaborar novos pensamentos, políticas e práticas que possam moldar o futuro do trabalho em uma direção mais justa e sustentável. O Instituto para a Economia Digital Cooperativa (ICDE)

Ele manifesta-se mais frequentemente nas escolas de negócios nas áreas de finanças, empreendedorismo e estudos organizacionais. Temas relevantes nas faculdades de direito incluem governança e

estrutura corporativa. Ao reconhecer essas lacunas, a missão do Instituto é fornecer pesquisas de valor genuíno para as cooperativas de plataforma existentes e potenciais. As pesquisas do Instituto agregam ao corpo de conhecimento que promove o empreendedorismo democrático na economia de plataforma.

INTRODUÇÃO

Domine seu futuro digital

Que tipo de nova economia queremos criar? As cooperativas de plataforma oferecem uma alternativa ao capitalismo de plataforma para o futuro próximo, com base em princípios cooperativos como propriedade democrática e governança. O Brasil é um país com uma longa história de cooperativas, as quais desempenham um papel crucial na economia. Um em cada cinco parlamentares no Brasil pertence a pelo menos uma cooperativa. Existem grandes empresas cooperativas nos setores financeiro, de saúde e agrícola. Mas e quanto a aplicação dos princípios cooperativos à economia digital visando impulsionar a propriedade democrática e a governança coletiva? Apesar da crescente digitalização do trabalho, dos serviços e da vida cotidiana, o número de

cooperativas de plataforma ainda é pequeno em comparação aos negócios tradicionais no Brasil. Tecnologias distribuídas e modelos de governança que têm recebido muita atenção, tais Organizações Autônomas Distribuídas e redes de blockchain, podem ajudar o país a ampliar as cooperativas de plataforma e cumprir os Objetivos de Desenvolvimento Sustentável da ONU. Eles terão impacto? Quem serão as principais organizações que apoiam esse movimento no Brasil? Ainda é muito cedo para dizer. O que está claro é que os formuladores de políticas podem ajudar esse setor a crescer criando um ambiente propício por meio de compras, assistência técnica, financiamento de startups, bem como a remoção de barreiras de entrada e a promulgação de regulamentos que nivelam o campo de atuação entre cooperativas de plataforma e empresas de tecnologia tradicionais. Em suma, ao apoiar as cooperativas de plataforma, os formuladores de políticas públicas podem contribuir para uma economia digital mais justa e sustentável.

Estimativas recentes indicam que 1 milhão e meio de motoristas e entregadores no Brasil trabalham por meio de plataformas digitais. Embora isso represente uma pequena fração da força de trabalho total do país, trata-se de uma tendência de rápido crescimento que tem impactado a economia brasileira significativamente.

E se esses entregadores pudessem ser donos de sua própria empresa? Essa é a premissa por trás das cooperativas de plataforma, que são empresas que vendem principalmente bens ou serviços digitalmente e administram plataformas por meio de tomadas de decisão democráticas e propriedade compartilhada. As cooperativas de plataforma são uma alternativa viável para os atuais desafios da economia digital. Elas representam caminhos concretos para novos modelos de propriedade, possíveis soluções para reduzir a desigualdade na *gig economy* e propostas para democratizar a internet.

Se quisermos construir uma sociedade mais justa, devemos revisar como os dados são processados na economia digital. Na América Latina, temos a oportunidade de construir uma economia digital cooperativa inovadora e assertiva. Mas quais são as instituições, políticas, negócios e tecnologias que promovem a infraestrutura cooperativa na América Latina?

Nos últimos oito anos, pessoas vindo de diferentes contextos sociais se reuniram sob a bandeira das "cooperativas de plataforma" para experimentar economias de plataforma alternativas. De médicos a agricultores, profissionais de limpeza doméstica a motoristas de táxi e artistas, esses esforços coletivos foram lançados em mais de 60 países.

Eles e elas são os mensageiros, influenciadores digitais e criadores de conteúdo que têm usado suas habilidades e criatividade para hackear o sistema e operar mudanças. Trata-se da luta por uma internet mais democrática e por trabalho digno na economia de plataforma. São também as feministas que estão reimaginando o mundo digital como um lugar onde elas podem administrar e possuir seus próprios negócios e construir um bem comum renovador.

Eles e elas estão construindo uma nova internet, que esteja enraizada no cuidado, na autonomia e na cura. Têm criado espaços online que centralizam vozes marginalizadas e se concentram na libertação coletiva. Lugares onde podem ser eles mesmos; lugares para a subsistência, para o amor e para a dignidade. Essas pessoas têm reimaginado o mundo digital como um lugar que eles administram e onde são os donos de si mesmos. Nesta nova internet, eles estão reivindicando seu poder e criando o futuro que desejam viver. E você também pode fazêlo.

Desde a *The Drivers Cooperative* de Nova York até a Coomappa de Araraquara e a Señoritas Courier, as cooperativas de plataforma constroem colaborativamente espaços para pessoas que estão na linha de frente do desejo de tornar essa imaginação realidade.

Com efeito, desde o início, Consórcio de Plataforma (Platform Cooperativismo Cooperativism Consortium - PCC), da The New School, tem estado na vanguarda desses esforços. Da análise de políticas conduzidas pelo nosso instituto de pesquisa ao estabelecimento de redes de solidariedade para apoiar os esforços emergentes neste setor, temos contribuído para essa luta de várias maneiras. O PCC se tornou um hub que ajuda esses grupos a começar, crescer ou converterse. Organizações irmãs foram estabelecidas na Alemanha, França, Indonésia e outros países. Por meio de seu programa de bolsas, o braço de pesquisa do PCC, o Instituto de Economia Digital Cooperativa (ICDE) dedica-se a estudar o tema da economia digital cooperativa. Uma vez por ano, pessoas que se dedicam a mudar o funcionamento da economia digital se reúnem para a conferência do PCC. Reuniões anteriores já ocorreram em Nova York, Hong Kong e Berlim.

O PCC estabeleceu parcerias com várias organizações para colaborar e expandir este trabalho, inclusive o Berkman Klein Center For Internet & Society da Universidade de Harvard, para explorar coletivos de dados, blockchain e confiança de dados; a Mondragón Corporation, visando fomentar a educação popular sobre economia digital e as cooperativas de plataforma; o USC/ Berggruen Institute, para publicar um documento informativo sobre políticas para cooperativas de plataforma; entre outros. Recentemente, o PCC e o ITS - Instituto de Tecnologia e Sociedade do Rio de Janeiro, desenvolveram o curso "Cripto, DAOs e Cooperativas", com amplo escopo no território brasileiro. As parcerias do PCC permitem à instituição recorrer a uma vasta gama de conhecimentos e experiências para atingir seu objetivo de promover o crescimento do setor cooperativo digital.

Este ano, o PCC se juntou ao ITS para trazer a Conferência do Consórcio de Cooperativismo de Plataforma ao Brasil, à América Latina e além. O ITS é uma organização independente, sem fins lucrativos, cuja missão é assegurar que o Brasil e o Sul Global respondam criativa e adequadamente às oportunidades proporcionadas pela tecnologia na era digital, e que seus potenciais benefícios sejam amplamente compartilhados pela sociedade. Além

de publicar análises, realizar eventos e oferecer cursos, o ITS está na vanguarda das discussões sobre tecnologia e seus efeitos na sociedade.

Um fórum sobre cooperativismo de plataforma e políticas públicas realizado em Porto Alegre, em junho de 2022, resultou na criação de um plano de ação para o cooperativismo de plataforma no Brasil com o objetivo de estabelecer um ecossistema de trabalho, tecnologias e desenvolvimento local. Inspirado pela publicação de Cooperativismo de Plataforma em 2017, muitos trabalhos importantes têm sido realizados no Brasil nos últimos anos.

A recente divulgação pública de um manifesto que examina as políticas públicas que viabilizarão o cooperativismo de plataforma no Brasil aumentou a coleta de assinaturas de apoiadores de movimentos sociais, lideranças cooperativas, figuras públicas e formuladores de políticas públicas.

Esta conferência também aborda vários temas subjacentes:

- A capacidade dos princípios cooperativos para fortalecer o bem-estar dos trabalhadores e reduzir as assimetrias de poder na economia digital;
- Os obstáculos significativos enfrentados pelas cooperativas, que incluem questões relacionadas ao acesso ao capital, assistência ao desenvolvimento de negócios, legislação e política de habilitação e a criação de federações pan- nacionais que compartilhem infraestrutura digital;
- Os mecanismos de governança necessários para garantir a máxima participação e voz das partes interessadas, tais como procedimentos

democráticos para melhorar os acordos de serviço, design de algoritmos e redução do impacto climático;

- As soluções necessárias para aumentar a resiliência, a igualdade racial e de gênero, o empoderamento do trabalho e a satisfação no trabalho no ecossistema de cooperativas existentes;
- A identificação de redes e necessidades existentes, antes de traçar soluções;
- A imaginação para criar uma nova geração de cooperativas de serviços compartilhados para trabalhadores autônomos, que utilizem infraestrutura digital para fornecer serviços personalizados aos membros distribuídos.
- A conscientização da opção cooperativa no âmbito de temas-chave, incluindo coletivos de dados versus colonialismo de dados, abordagem de *crowdfunding* (financiamento coletivo) versus investimentos de capital de risco, cooperação versus competição e governança distribuída versus governança centralizada.
- Trabalho prático e proativo de coordenação do setor global para evitar a reinvenção da roda e, em vez disso, formar federações e compartilhar infraestrutura digital globalmente, ou seja, o tipo de trabalho que vai além de representação e análise.

Embora a maioria das conferências siga a cartilha acadêmica, estamos dando um passo adiante ao reunir não apenas acadêmicos e pesquisadores, mas também trabalhadores, organizadores, artistas, empresários, formuladores de políticas e movimentos sociais em vários formatos.

O objetivo desta conferência é estabelecer soluções alternativas para a economia digital, não apenas incentivar os operadores históricos a agirem de forma mais ética. Com base em longas histórias de lutas dos trabalhadores e trabalhando ao lado de aliados em diversos movimentos sociais, nosso objetivo é criar sistemas inteiramente novos que funcionem para todos. Uma vez que se trata de um encontro com foco no Brasil e na América Latina, este evento une os vários esforços da região para construir uma internet mais justa e democrática. Com esse futuro em mente, convidamos você ao Museu do Amanhã, no Rio de Janeiro, para dar o pontapé inicial em seu próprio futuro digital.

Aline Os é a fundadora do Señoritas Courier, um coletivo de entregas formado por mulheres

e pessoas LGBTQIAP+ sediado em São Paulo. O que torna o Señoritas único é sua estrutura horizontal e tomada de decisão coletiva. Em outras palavras, seus membros definem como o negócio deverá ser gerenciado. Isso contrasta com a maioria dos serviços de entrega, que tendem a ser altamente centralizados e empregam plataformas de alta tecnologia que permitem pouca participação dos trabalhadores. Para o Señoritas Courier é importante olhar para as pessoas que compõem o coletivo como seres holísticos, dotados de necessidades e desejos que vão além de simplesmente fazer entregas. [português]

Jacira Sousa acredita que sua organização também pode ajudar a abordar outras guestões sociais, tais como acesso à cidade, tecnologia e saúde. A relação entre o corpo coletivo e a tecnologia é primordial, e a primeira é vista como um componente essencial para o desenvolvimento do trabalho, por meio de ações internas para a inclusão digital das pessoas do coletivo. O coletivo Señoritas Courier tem tudo a ver com soluções que pretendem hackear e subverter a lógica do lucro

como objetivo final, priorizando as boas relações e condições de trabalho. [português]

AppJusto

O AppJusto é um novo aplicativo de entrega que adota uma abordagem mais justa para a gig economy. Ao contrário de outros aplicativos de entrega, o Applusto permite que os trabalhadores definam seus próprios preços para entregas e não há sistema de classificação entre os trabalhadores. Como explica Pedro Andrade, o aplicativo tem código aberto e é financiado coletivamente, o que significa que pode servir de inspiração para outras cooperativas. O Applusto repensa o modelo de plataforma de entrega de alimentos como um "bem coletivo" em que a empresa não cobra taxas de transação do entregador. [português]

Contrate Quem Luta

Edson Sousa apresentará o Contrate Quem Luta, um assistente virtual criado pelo Movimento dos Trabalhadores Sem-Teto. O assistente conecta moradores de rua que buscam trabalho a pessoas que buscam serviços como limpeza ou

pintura. A tecnologia, que é gratuita para os trabalhadores, funciona por meio do WhatsApp e já foi utilizada mais de 3.000 vezes. As informações pessoais dos trabalhadores não são compartilhadas com os clientes. [português]

Cataki

A Cataki é uma plataforma gratuita que conecta catadores de lixo a indivíduos e organizações que precisam reciclar seus resíduos residenciais ou comerciais. No Brasil, mais de 300 mil pessoas já baixaram o aplicativo. Mais de 4.500 catadores de lixo em mais de 1.700 cidades utilizam o software. O aplicativo Cataki também oferece suporte a mais de 300 cooperativas de reciclagem. Apresentado na conferência por seu fundador, Mundano, o aplicativo foi desenvolvido para ajudar a comunidade de catadores a aumentar seus ganhos, identificar novos parceiros e localizar os melhores locais para vender seus materiais recicláveis. A plataforma Cataki também é utilizada pela organização sem fins lucrativos "Pimp my Carroça", que é

responsável pela criação do Cataki. *[português]*

Um dos destaques do primeiro dia da conferência traz **Trebor Scholz** e **Ronaldo Lemos** em uma conversa com **Aline Os** e **Jacira Sousa**. Aline e Jacira são integrantes do Señoritas Courier, um coletivo que busca desenvolver uma plataforma de entrega de propriedade de mulheres e membros da

comunidade LGBTQIAP+ na cidade de São Paulo. Jacira explica: "Tradicionalmente, os serviços de entrega eram baseados em propriedade e operados por homens cisgêneros. O Señoritas está mudando isso, ao oferecer oportunidades de trabalho para pessoas queer. Aline ecoa o sentimento, acrescentando que a Señoritas é "boa não apenas para a comunidade LGBTQIAP+, mas também para as empresas que contratam nossos serviços". Graças a coletivos como o Señoritas Couriers, o setor de entregas tem se tornado mais inclusivo. Como pesquisador, escritor, professor e diretor fundador do Consórcio de Cooperativismo de Plataforma (PCC), na The New School de Nova York, Trebor Scholz tem sido muito influente na formação da economia digital cooperativa como uma resposta construtiva e esperançosa para o capitalismo de plataforma. Ele argumenta que para construir uma internet democrática, devemos primeiramente criar uma economia digital de propriedade e operação cooperativa como parte de um conjunto de ferramentas de economia solidária mais amplo.

Ronaldo Lemos é um advogado brasileiro, professor de Direito, autor, cofundador do ITS, coautor do Marco Civil da Internet no Brasil e membro do Conselho da Agenda Global do Fórum Econômico Mundial sobre o Futuro da Internet, associado ao Fórum Econômico Mundial. Este bate-papo entre Scholz, Os, Sousa e Lemos irá preparar o terreno para a conferência e abordará algumas ideias concretas sobre como podemos construir uma economia digital cooperativa. Algumas das principais questões que eles discutirão incluem: O que é uma plataforma cooperativa? Quais são os princípios da economia digital cooperativa? Como podemos construir um ecossistema de cooperativas que possa competir com os incumbentes? [inglês] & [português]

Nesta sessão, Steibel, membro do Conselho Global do Fórum Econômico Mundial e diretorexecutivo do ITS, discutirá os desenvolvimentos recentes e acrescentará a perspectiva do ITS, um dos mais respeitados institutos de pesquisa em tecnologia do Brasil. Steibel discutirá as sutilezas da conexão entre as cooperativas e a advocacia legislativa, bem como as dificuldades enfrentadas pelos aspirantes a grupos de base que buscam causar impacto. Como exemplo da agenda de governo aberto adotada no Brasil, ele discute o papel atual das cooperativas na influência das instituições políticas. Em seguida, ele abordará as particularidades das organizações coletivas do país, que criam tensões entre novas e velhas organizações. [português]

Os relatórios do PCC/ITS de Rafael Zanatta e do PCC/Berggruen Institute, de Trebor Scholz et al., são dois importantes estudos que investigam como os formuladores de políticas municipais podem e apoiam a expansão das cooperativas de plataforma. Os relatórios

ilustram como os legisladores municipais no Brasil e além podem promover um ambiente propício para esse movimento. Ao fazê-lo, eles podem contribuir para a criação de trabalho digno, o desenvolvimento de comunidades resilientes e o avanço da democracia econômica no Brasil. [português]

Novas estratégias para o trabalho de plataforma na América Latina

A Fairwork Foundation tem trabalhado na América Latina para ajudar os trabalhadores da economia de plataforma. A gig economy tem se expandido rapidamente pelo Chile e a migração internacional tem contribuído para essa expansão. Nos últimos anos, o Equador testemunhou um aumento no trabalho baseado em plataforma, mas apenas uma ínfima parte é justa ou digna. De acordo com o relatório da Fairwork Foundation sobre o trabalho de plataforma no Equador, o governo deve tomar medidas para garantir que todos os trabalhadores sejam protegidos pelas leis trabalhistas. Além disso, na América Latina, há também um movimento crescente de trabalhadores que desejam estabelecer suas próprias cooperativas de plataforma. Os palestrantes defendem que o governo crie um ambiente regulatório favorável às cooperativas de plataforma e invista em programas de alfabetização digital para trabalhadores interessados em estabelecer suas próprias cooperativas. Um relatório sobre o trabalho da Fairwork Foundation na América Latina

A Fairwork Foundation é uma organização de pesquisa e política que se concentra na promoção de práticas de trabalho justas em diversos países. A fundação foi criada em 2015 em resposta às crescentes preocupações quanto à proliferação de empregos de baixa qualidade e o declínio do padrão de direitos e proteções trabalhistas, especialmente entre os trabalhadores de plataformas. Desde então, a Fairwork Foundation tem contribuído significativamente para pesquisas e debates políticos sobre tais questões. À medida que o debate sobre o futuro do trabalho continua a se intensificar, a Fairwork Foundation continuará a fornecer classificações para plataformas de trabalho de plataforma, bem como recomendações de políticas para líderes governamentais e empresariais. Os pesquisadores Jonas Valente e Alessio Bertolini apresentarão este trabalho. [inglês]

Qual é o papel da migração internacional na *gig economy* no Chile?

O Chile tem visto um aumento na migração internacional nos últimos anos. Esse fenômeno tem coincidido com o crescimento da gig economy, que criou novas oportunidades de emprego para os migrantes. No entanto, esses empregos são frequentemente mal remunerados e precários, e os trabalhadores migrantes frequentemente enfrentam condições de trabalho desafiadoras. Mesmo assim, muitos deles têm encontrado maneiras de lutar por seus direitos e resistir a essas condições. Por exemplo, o coletivo Riders Unidos Ya no Chile tem se organizado contra a empresa Pedidos Ya, que foi acusada de exploração e condições precárias de trabalho. Essas condições se deterioraram desde o início da pandemia, mas os trabalhadores migrantes continuaram a lutar por seus direitos. Esta palestra apresentada por **Macarena Bonhomme** se concentrará no papel da migração internacional e da *gig economy* no Chile, bem como em como os migrantes têm resistido à exploração e à precariedade. Construindo as cooperativas de plataforma chilenas: por que e como Matías Bertranou

No Chile, as cooperativas de plataforma têm potencial para se tornarem uma força poderosa para o bem comum. Esta apresentação de **Matías Bertranou** se concentrará no contexto chileno das cooperativas de plataforma, incluindo os desafios de iniciar cooperativas em um setor emergente. Também serão analisadas as semelhanças entre as cooperativas de plataforma e as cooperativas tradicionais, bem como de que maneira as cooperativas de plataforma podem ser usadas para aumentar as oportunidades de empreendedorismo no Chile. Apresentando a Cooperativa de Dados: uma nova abordagem para agrupamento e

compartilhamento de dados

No ano passado, detectamos um interesse crescente no conceito de cooperativas de dados. Uma cooperativa de dados é uma organização que pertence e é controlada por seus membros, que agrupam seus dados para criarem recursos compartilhados. Em seguida, a cooperativa usa esses dados para prestar serviços aos seus associados. O modelo oferece uma série de vantagens, entre elas o fato de dar aos membros mais controle e acesso aos seus dados, além de permitir a criação de um círculo virtuoso no qual os dados são utilizados para melhorar a qualidade dos serviços oferecidos pela cooperativa. Esta sessão explorará o potencial das cooperativas de dados e discutirá alguns dos desafios que precisam ser superados para levá-los ao sucesso.

Descentralização de dados: como os países têm usado a legislação para exercer controle

Nos últimos anos, o controle de dados tornou-se mais localizado e descentralizado. Preocupações com a privacidade e segurança de dados, um desejo de obter mais controle local sobre a tomada de decisões orientada por dados e a aspiração de promover a concorrência e a inovação na economia digital têm impulsionado esse movimento. Vários países ao redor do mundo têm operado a descentralização do controle do uso de dados. Nos Estados Unidos, esse movimento foi liderado pelo estado da Califórnia. A Lei Geral de Proteção de Dados da Califórnia, datada de 2018, concedeu aos residentes novos direitos sobre seus dados pessoais. A lei estabeleceu que a Agência de Proteção de Dados do Procurador-Geral deverá fazer valer esses direitos. Por sua vez, a Lei de Privacidade do Consumidor da Califórnia, de 2019, conferiu aos residentes mais controle sobre seus dados pessoais. Outros estados e países têm adotado essas leis como modelo. **Katya Abazajian**, pesquisadora do ICDE, discute a política estadual e local que as cooperativas de dados devem conhecer para trabalhar em nível local, usando a Califórnia como estudo de caso. Cooperativas de Dados: o que, por que e como

Adriane Clomax, atual pesquisadora do ICDE, abordará temas introdutórios sobre as cooperativas de dados. Ela observa que as cooperativas de dados, como parte do cenário das cooperativas de plataforma, existem e prosperam de acordo com certos parâmetros. Elas são cooperativas orientadas para o bem-estar social e que possuem um modelo de negócios em que os associados controlam e acessam os dados gerados. As vantagens desse modelo são inúmeras, inclusive por permitir uma tomada de decisão mais democrática sobre como os dados serão capturados e usados. Ele dá aos membros uma maior participação no valor que é criado a partir de seus dados, além de criar valor social e econômico para suas comunidades. [inglês]

Dados abertos e Cidades Inteligentes

Como os dados abertos podem contar com a governança cooperativa para fortalecer as comunidades e ajudar as cidades a enfrentar os desafios sociais e econômicos que vêm pela frente? Como as cooperativas podem compartilhar dados e fomentar a colaboração em infraestrutura tecnológica entre seus membros? Esses são apenas alguns dos tópicos que **Ana Carolina Benelli** abordará neste painel, que apresentará exemplos reais de prefeituras, cooperativas de saúde e agropecuária e soluções de tecnologia da informação direcionadas ao uso de dados para o bem-estar social. [português]

Portfólios de trabalhadores portáteis para a *gig economy* Martijn Arets compreende os desafios únicos que vem a reboque da *gig economy*, especialmente a falta de portfólios portáteis. Por essa razão, ele criou a GigCV, uma ferramenta fácil para quem trabalha ou acumula experiência de trabalho a partir da *gig economy.* Com esse padrão aberto, os trabalhadores temporários podem baixar facilmente seus próprios dados de reputação e transações, que servem como prova de sua experiência de trabalho e habilidades em plataformas conectadas. A

GigCV está disponível para 50 mil trabalhadores na Holanda. [inglês]

Apresentando a Needs Map: a resiliência diante da pobreza e do desastre

Evren Aydoğan falará sobre como a plataforma cooperativa Needs Map pode ajudar a melhorar a vida de milhões de pessoas em todo o mundo. A Needs Map se vale do cooperativismo de plataforma como a pedra angular de um novo tipo de solidariedade social baseada na comunidade para reduzir os desafios associados à pobreza e aos desastres naturais. Ela utiliza a tecnologia do Sistema de Informações Geográficas (SIG) para analisar e apresentar dados geograficamente referenciados e ajudar comunidades e cooperativas/organizações não governamentais a se tornarem mais resilientes. O Needs

Map integra o modelo fintech, por exemplo, para apoiar o crescimento de mercados sociais locais/cooperativos. Isso facilitará a conexão imediata dos indivíduos necessitados com os serviços e recursos disponíveis. Em última análise, a plataforma Needs Map oferece uma perspectiva alternativa sobre a relação entre as pessoas e a tecnologia, que pode nos ajudar a construir um mundo mais justo e igualitário.

As cooperativas podem resolver os problemas de governança das DAOs?

Local: Auditório Guiado por: Trebor Scholz [inglês]

À medida que o interesse em organizações autônomas descentralizadas (DAOs) cresce, é fundamental considerar os desafios futuros que elas poderão enfrentar. Uma questão crítica é a governança. As cooperativas, por outro lado, possuem uma longa história que pode nos ensinar a superar esses obstáculos. Os desenvolvedores podem aprender como construir DAOs mais resilientes e eficazes estudando os sucessos e fracassos das cooperativas.

Uma introdução à *blockchain* e às

Organizações Autônomas Distribuídas

Ronnie Paskin é um especialista em *blockchain* e um nome bastante conhecido no setor de TI, tendo trabalhado mais de três décadas como engenheiro de software. Paskin também é pesquisador da PUC-Rio. Nessa sessão, ele nos apresentará noções sobre tecnologias distribuídas e Organizações Autônomas Distribuídas. A experiência de Ronnie no campo de *blockchain* o torna excepcionalmente qualificado para falar sobre esse tópico. Além de sua atuação no setor privado, ele já trabalhou com startups no Brasil e nos EUA e instituições de ensino profundamente comprometidas com as questões sociais. Como resultado, ele possui profundo conhecimento dos aspectos técnicos dos sistemas distribuídos e das implicações sociais dessas tecnologias. [inglês] &

As preocupações relacionadas à governança corporativa e trabalhista nas DAOs

Morshed Mannan argumenta que um número crescente de DAOs tem levado à criação de

novas formas de governança corporativa. Os DAOs são gerenciados por algoritmos que automatizam diversas tarefas de governança em vez de atribuí-las a um conselho de administração central. Essa tática corrige alguns problemas envolvendo a governança corporativa tradicional, mas também introduz novos desafios devido à incompletude inerente aos contratos. Este fenômeno é descrito como o problema da "governança corporativa por design". Esta palestra servirá como uma mensagem de advertência às DAOs cooperativas emergentes, ao destacar possíveis problemas de governança com os quais elas podem se deparar no futuro. Também será discutido o fenômeno de um grupo crescente de pessoas trabalhando por meio e para as DAOs, o que sucinta questões sobre que direitos deveriam ser concedidos a eles. Para ter acesso aos direitos dos trabalhadores, é essencial reconhecer alguns membros da DAO como trabalhadores. Com relação a tais preocupações envolvendo governança, a história das cooperativas, a aplicação da lei trabalhista às

cooperativas de trabalhadores e a governança das cooperativas de trabalhadores oferecem lições salutares.

Como os desenvolvedores podem aprender com a história das cooperativas

Jad Esber é um empreendedor e *product builder* interessado em tecnologias descentralizadas e suas aplicações. Esber também está interessado na história das cooperativas e nos principais aprendizados que podem ser aplicados no desenvolvimento de novas plataformas e protocolos de internet. Ele argumenta que as cooperativas têm tido sucesso na criação de modelos alternativos de propriedade e controle, mas também têm enfrentado desafios em termos de escalabilidade. Consequentemente, ele investigou como desenvolvedores e empresas emergentes do setor de internet podem aprender com a história compartilhada das cooperativas e como, na prática, eles podem construir sistemas que respeitem os ideais cooperativos. Fazendo a ponte entre a blockchain e os recursos comuns

Particularmente no contexto das cooperativas, há um interesse crescente em plataformas descentralizadas. A justificativa para a seleção de plataformas descentralizadas em vez de centralizadas é frequentemente baseada no conceito de bens comuns ("commons"). Os bens comuns são recursos de propriedade comunitária, em oposição àqueles pertencentes a um indivíduo ou corporação. Acredita-se que a tecnologia blockchain é adequada para gerenciar os bens comuns pois esta pode facilitar a formação de relacionamentos peer-topeer que não sejam baseadas em confiança. Já existem várias cooperativas que utilizam a tecnologia blockchain, incluindo a Dork.tech. As organizações autônomas descentralizadas (DAOs) são um tipo de plataforma descentralizada cujos recursos de governança têm ganhado popularidade. As DAOs são organizadas em torno de contratos inteligentes "smart contracts"), que se executam e fazem valer as regras da organização. Dependendo do contexto, as condições específicas que tornam as DAOs preferíveis às plataformas centralizadas podem incluir maior transparência, responsabilidade e controle para seus membros. Isto é, a tecnologia blockchain oferece às cooperativas novas oportunidades para se autogovernarem de maneira mais consistente com os valores dos bens comuns. A pesquisa de **Philémon Poux** está centrada nesta discussão. [inglês]

As abordagens baseadas em bens comuns têm sido adotadas por cooperativas e outras organizações culturais. Tais estratégias se baseiam no compartilhamento de recursos e conhecimentos para o bem comum. Com efeito, as estratégias baseadas em bens comuns têm ajudado a preservar bilhões de imagens e podem ser igualmente eficazes na proteção

dos direitos dos artistas. As cooperativas de plataforma parecem ser adequadas para abordagens do gênero, pois podem melhorar a vida dos trabalhadores culturais ao reunir recursos e conhecimentos.

Como você pode ajudar a preservar bilhões de fotos

Em 2022, a Flickr Inc. fundou a Fundação Flickr para preservar seu corpus de bilhões de imagens. A Fundação valoriza a propriedade comunitária dessas fotografias e intenta preserválas pelos próximos 100 anos. Isso deverá ser alcança em parte, educando o público em geral sobre como proteger a arte e a cultura, enfatizando a importância da preservação de histórias digitais recentes. Para isso, a Fundação Flickr aplicará a teoria dos bens comuns para propor políticas que preparem essa vasta coleção de forma mais deliberada para o domínio público no futuro e impeçam o uso não autorizado de imagens armazenadas em seu site. O bolsista do ICDE, George Oates, apresentará este importante trabalho. [inglês]

Igualdade para artistas brasileiros: um estudo crítico das cooperativas de plataforma

O Brasil possui uma rica herança cultural e muita criatividade, mas também níveis significativos de desigualdade, tornando desafiador que seus artistas encontrem espaços acessíveis para trabalharem e viverem de sua arte. O bolsista do ICDE **Victor Barcellos** investiga como as cooperativas de plataforma podem melhorar as condições de trabalho dos artistas no país. Elas podem, por exemplo, servir como mercados online para artistas, concedendo-lhes maior autonomia e controle, bem como remunerações mais equitativas. Ao reconhecer a arte como um bem público, tais cooperativas de plataforma também podem ajudar a tornar a arte acessível a todos. Dessa forma, as cooperativas de plataforma e o movimento de cultura livre podem trabalhar juntos para ajudar a sustentar a comunidade artística brasileira. [português]

O poder das estratégias baseadas em bens comuns para as cooperativas do Sul Global

Quais são as possíveis conexões entre os bens comuns e as cooperativas? Com base em sua pesquisa sobre teorias e práticas relacionadas aos bens comuns, Miguel Said Vieira argumenta que as cooperativas podem se tornar mais impactantes e inclusivas ao compreender e empregar estratégias baseadas nesse tipo de recurso, particularmente no Sul Global. Uma abordagem baseada em bens comuns lhes proporcionaria acesso a uma riqueza de recursos e conhecimento, bem como a capacidade de se engajar em ações coletivas. Por fim, Vieira argumenta que as teorias dos *commons* podem inspirar novos modelos de tomada de decisão cooperativa que sejam mais responsivos às necessidades dos membros. [português]

A cultura livre pode salvar as cooperativas de plataforma no setor cultural?

Nos últimos anos, a resistência à mercantilização da cultura ganhou força. **Leonardo Foletto** é uma das figuras mais proeminentes desse movimento,

também conhecido como Movimento Cultura Livre. Em seu novo livro, A Cultura é Livre: Uma História da Resistência *Antipropriedade,* para o qual Gilberto Gil escreveu o prefácio, o autor discute o papel que o Creative Commons pode desempenhar no movimento da cultura livre. A Creative Commons é uma organização sem fins lucrativos que oferece um conjunto de licenças de direitos autorais que permitem aos criadores compartilhar seu trabalho sem renunciar a todos os seus direitos. Essa pode ser uma ferramenta útil para criadores que desejam tornar seu trabalho acessível ao público, ao mesmo tempo em que mantêm algum controle sobre seu uso. Por fim, Foletto pondera como o movimento de cultura livre pode inspirar cooperativas de plataforma no setor cultural. [português]

Erik Forman é o cofundador da The Drivers Cooperative, uma organização que conta com mais de 7.500 motoristas de veículos de aluquel na cidade de Nova York. Até agora, a cooperativa conseguiu estabelecer um salário mínimo de US\$ 30/h para suas principais linhas de negócios e pagou mais de US\$ 4 milhões em salários aos motoristas este ano. Atualmente, a The Drivers Cooperative busca globalizar a propriedade dos trabalhadores na economia de plataforma por meio da criação de uma federação mundial de cooperativas de motoristas. [inglês]

Novas estratégias de criação de empregos no Brasil

Uma nova política pública tem criado empregos e reduzido a pobreza na cidade de Araraquara. A prefeitura auxiliou a criação de duas cooperativas de plataforma que abordam os temas dos baixos salários e da precariedade do trabalho da *gig*

economy, principalmente durante a pandemia. O sucesso de Araraquara mostra que políticas de apoio podem efetivamente estimular a existência desses negócios.

De Araraquara, Brasil: Um modelo de políticas públicas para a criação de cooperativas de plataforma

Precisando de uma carona? Conheça a mais nova cooperativa de motoristas do Brasil! O programa Coopera Araraquara é uma política pública que visa estimular a criação, o desenvolvimento, a consolidação, a sustentabilidade e a expansão de cooperativas e outros grupos associativos, por meio de uma incubadora de empresas públicas solidárias. Como gestora do programa, Vivian Pacheco tem apoiado a criação de uma cooperativa de motoristas (Morada Car) e uma cooperativa de distribuição de alimentos (Morada Express) na cidade de Araraquara, no estado de São Paulo. A prefeitura municipal enxerga a economia solidária como um importante caminho para o desenvolvimento social e econômico. Ao contratar cooperativas, a cidade também

pode ajudar a melhorar sua oferta de serviços públicos. [português]

Uma nova maneira de gerar empregos no Brasil

O Ministério Público do Trabalho (MPT) é uma parte importante do ordenamento jurídico do país. O Ministério é responsável por fazer valer as leis trabalhistas e proteger os direitos dos trabalhadores. Como promotor público, Renan Kalil é um defensor dos direitos dos trabalhadores e tem defendido melhores condições de trabalho e salvaguardas antiexploração mais fortes. Ele também criticou o impacto da pandemia sobre os trabalhadores brasileiros, principalmente do setor informal. Kalil recentemente defendeu a expansão das cooperativas de plataforma como forma de criar empregos mais seguros e sustentáveis, melhorando a vida dos trabalhadores brasileiros e reduzindo a pobreza. [português]

As cooperativas de plataforma no âmbito da regulação de plataformas Alexandre Costa Barbosa,

consultor especialista do Comitê Gestor da Internet no

Brasil, apresentará o escopo da regulação de plataformas em discussão no Brasil, considerando a tipologia de plataformas e até que ponto as cooperativas de plataforma podem ser fortalecidas. Ele discutirá a competição de plataforma, bem como os limites das cooperativas de plataforma. Compreender os vários tipos de cooperativas de plataforma nos permite criar melhores políticas para apoiálas. Além disso, ao entender a competição de plataforma, podemos aprender a tornar as condições mais equitativas para que as cooperativas possam prosperar. Por fim, Barbosa apresentará o aspecto multissetorial da Governança da Internet e o protagonismo do Brasil nesse sentido, trazendo reflexões para a governança de cooperativas de plataforma. Da Índia e da Itália ao Senado dos EUA: o que a política pode fazer para desencadear o poder das cooperativas digitais

O que começou como um nicho criado por apenas alguns indivíduos com experiência em tecnologia se transformou em um movimento global com apoiadores em quase todos os países. A partir de uma série de iniciativas em andamento, parece que o estado indiano de Kerala tem liderado o desenvolvimento cooperativo digital. Durante décadas, as cooperativas italianas ajudaram as pessoas a quebrar o ciclo da pobreza. As cooperativas são apoiadas e promovidas por senadores de ambos os partidos nos Estados Unidos. Este fórum fornecerá perspectivas globais sobre iniciativas políticas neste setor.

Um estado indiano lidera o caminho

Mohit Dave se concentrou no crescimento de cooperativas de plataforma no sul da Índia, particularmente a partir de Kerala

por meio de organizações como o Conselho de Estratégia de Desenvolvimento e Inovação de Kerala, um think-tank estratégico e órgão consultivo estabelecido pelo governo de Kerala. Como pesquisador da International Cooperative Alliance, ele estuda o cenário das cooperativas (de plataforma) na região da Asia-Pacífico. Mohit também realizou pesquisas sobre o impacto das cooperativas nos ODS, sua resiliência na pandemia de COVID-19 e sua relevância na Economia Social e Solidária. Ele está envolvido em diversas iniciativas que visam construir uma rede de influenciadores e instituições investidas em cooperativas de plataforma para engajá-los de forma significativa. [inglês]

É hora de convencer o Senado dos EUA

Sadev Parikh, um atual membro do ICDE, está em uma missão para tornar as cooperativas de plataforma mais palatáveis para os senadores dos Estados Unidos. Em um artigo recente, ele descreve quatro alavancas que podem ser usadas para incentivar o crescimento desses negócios: legislação antitruste,

interoperabilidade, legislação de privacidade e apoio da Small Business Administration (SBA). A SBA é uma agência do governo federal americano que fornece empréstimos e outras assistências a pequenas empresas. Fazer com que os governos estaduais e locais implementem políticas que incentivem a propriedade dos funcionários pode ser uma maneira de assegurar que a SBA apoie as cooperativas. Por exemplo, a cidade de Pittsburgh criou uma força tarefa sobre propriedade de funcionários que tem atuado para promover esse modelo de negócios. Os senadores que apoiam as pequenas empresas e promovem a concorrência podem ser particularmente receptivos a essas ideias. Ao usar essas alavancas, podemos criar um ambiente mais propício ao crescimento das cooperativas de plataforma. [inglês]

Um relatório sobre Bolonha, Milano e Biella

Pietro Ghirlanda é um acadêmico italiano que se concentra no papel das cooperativas de plataforma no contexto italiano. Ele realizou

estudos de caso em três cidades italianas: Bolonha, Milão e Biella. Em cada uma dessas três cidades, ele estudou como os municípios apoiam as cooperativas de plataforma e as plataformas sociais e solidárias avaliando seu histórico, proposta de valor, modelo organizacional, vantagens competitivas, elementos paradigmáticos e entrevistando os principais *stakeholders* envolvidos em três exemplos emblemáticos: A Plataforma Vicoo, So.De e Welfare X. Ghirlanda adota uma perspectiva ecossistêmica e institucionalista, fazendo referência também à literatura sobre bens comuns. [inglês]

Esta palestra apresentada por um dos mais ativos proponentes acadêmicos do cooperativismo de plataforma, Rafael Grohmann, enfocará as possibilidades teóricas e de políticas públicas para construção do cooperativismo de plataforma na América Latina. Assim, a apresentação terá quatro seções: (1) O conceito de plataformas de propriedade dos trabalhadores e seu lugar na discussão sobre o trabalho de plataforma e o cooperativismo de plataforma, em relação à circulação global das lutas dos trabalhadores; (2) teorização sobre o cooperativismo de plataforma da América Latina, levando em conta os aprendizados históricos da região em relação ao desenvolvimento de tecnologias e organização do trabalho, e também de autores como Jesús Martín-Barbero, Alvaro Vieira Pinto e os debates atuais sobre Big Dados e IA no âmbito do Sul. Isso significa que o cooperativismo de plataforma do Sul não pode constituir uma mera "tropicalização" do conceito, mas um esforço de teorização que venha de baixo; (3) a partir das lições aprendidas, um convite a imaginar possibilidades prefigurativas de tecnologias de

propriedade do trabalhador e sua relação com um circuito mais amplo de produção e consumo que conecte passado, presente e futuro; (4) elaboração de uma agenda de políticas públicas para plataformas de propriedade dos trabalhadores em diálogo com trabalhadores, governos e formuladores de políticas. A palestra de Rafael Grohmann sobre o cooperativismo de plataforma na América Latina sem dúvida inspirará o avanço das cooperativas de plataforma na região. Grohmann tem defendido um movimento de cooperação de plataforma especificamente voltado para as necessidades das pessoas no Brasil, levando em consideração o contexto cultural e econômico distinto do país e corretamente rejeitando a simples "importação" das estruturas organizacionais do Norte Global. 

Rosana Pinheiro-Machado releva como a extrema direita está mobilizando trabalhadores de plataforma

Um dos motores mais significativos do crescimento da extrema direita é o uso de plataformas digitais para difundir ideologias extremistas. Rosana

Pinheiro-Machado, especialista em movimentos de extrema direita, explica como essas plataformas têm sido usadas para atingir novos públicos e recrutar membros. "Existe uma rede muito ativa de YouTubers de extrema direita e páginas do Facebook que têm disseminado conteúdo que oferece às pessoas uma visão muito distorcida do mundo", diz. "E não se trata apenas de informações sobre política ou imigração; também há teorias da conspiração e notícias falsas". Esse conteúdo é frequentemente amplificado por algoritmos que favorecem o engajamento em detrimento da precisão, criando um ciclo de feedback que impulsiona ainda mais o crescimento da extremadireita. Embora sejam muitos os fatores que contribuem para a ascensão da extrema direita, Pinheiro-Machado acredita que o uso de plataformas digitais é um dos mais importantes. Modelos alternativos de mídia social poderiam contrariar esses desenvolvimentos? [português]

Vigilância do local de trabalho em plataformas digitais

Fernanda Bruno fala sobre o monitoramento excessivo dos trabalhadores de plataforma. Ela argumenta que a tecnologia que esses trabalhadores usam constantemente os observa e os controla, impactando negativamente suas vidas pessoais e profissionais. Empregar tecnologia alternativa e organizar a resistência são apenas algumas das estratégias que Bruno sugere para frustrar esse monitoramento e controle. Embora algumas dessas estratégias possam ser mais bem sucedidas do que outras, todas elas fornecem aos trabalhadores da plataforma uma maneira de recuperar algum grau de controle sobre seu local de trabalho. Unisol: Protegendo os direitos dos trabalhadores informais no Brasil

A Unisol, Central de Cooperativas e Empreendimentos Solidárias, é um desdobramento do movimento sindical brasileiro e do movimento político

progressista. Originalmente, foi criada pelo sindicato dos metalúrgicos do Partido dos Trabalhadores (PT) e é membro da Aliança Cooperativa Internacional. O objetivo declarado da Unisol é proteger e promover os interesses dos trabalhadores da chamada "economia informal" – aqueles que não são protegidos pelas leis trabalhistas tradicionais e não têm o poder de barganha que vem a reboque do emprego formal. Nos últimos anos, a Unisol tem estado na vanguarda dos esforços para lidar com a exploração de trabalhadores temporários e outros setores vulneráveis da força de trabalho.

Leo Pinho vai discutir o problema dos trabalhadores sem direitos, novas propostas de regulamentação do trabalho e cooperativas de plataforma como alternativa para ter mais poder de negociação. [português]

As cooperativas de plataforma podem ajudar o País Basco e mais além, o Sul Global?

O País Basco possui uma forte cultura empresarial cooperativa. Essa tradição cooperativa ajudou o País Basco a enfrentar várias crises econômicas e pode estabelecer as bases para que essa região se torne um centro importante para as cooperativas digitais. Since 2008, he has created thoughtprovoking art using the posters and banners that spruce up Brazilian cities during elections. For the 2014 election, he transformed these enormous plastic banners into a massive voting booth filled with trash in a Rio de Janeiro square. "I use these ads to get people to think about the corrupted political system. On all the broken promises and heinous waste," he explains.

The Platform Cooperativism Consortium (PCC)

The Platform Cooperativism Consortium, or PCC, is a group of researchers and activists from all over the world who are trying to build a digital economy that is more democratic, fair, and decentralized for workers and communities. We do this by encouraging the use of cooperative principles in platform work and the infrastructure of the Internet. These principles are: voluntary and open membership; democratic member control; member economic participation; autonomy and independence; education, training, and information; cooperation among cooperatives; and concern for community. We do this through the creation of policy analysis, resources such as our directory and extensive library, research (e.g., our

fellowship reports), community building (annual conferences and programming), courses, consulting, and global coordination. We work with startups, existing cooperatives, academics, policymakers, funders, and allies in other movements to build a coalition for system change. PCC's members are working together to develop new thinking, policies, and practices that can shape the future of work in a more just and sustainable direction. 
The Institute for the Cooperative Digital Economy (ICDE)

The where, when, and how of work is changing. Artificial intelligence, automation, and data processing continue to shift control away from workers to digital systems. These disruptions are frequently unpredictable and are still unfolding. To navigate these challenges, we need research that imagines and investigates new visions of a more equitable future of work. The cooperative digital economy, an emerging field related to labor studies and cooperative studies, is under-researched in the fields of anthropology, political science, sociology, history, and economics. It manifests itself in business schools in the areas of finance, entrepreneurship, and organizational studies. Relevant subjects in law schools are governance and corporate structure. Recognizing these research gaps, the Institute's mission is to provide research of genuine value to prospective and existing platform cooperatives. The

research of the Institute adds to the body of knowledge that promotes democratic entrepreneurship in the platform economy.

INTRODUCTION

Own Your Digital Future

What kind of new economy do we want to create? Platform co-ops offer a near-future alternative to platform capitalism based on cooperative principles such as democratic ownership and governance. Brazil is a country with a long history of cooperatives; they play an important role in the economy. One out of every five members of Congress in Brazil belongs to at least one cooperative. Large cooperative enterprises exist in the financial, healthcare, and agricultural sectors. But what about applying cooperative principles to the digital economy to boost democratic ownership and collective governance? Despite the increasing digitization of work, services, and everyday life, the number of platform cooperatives is still small in comparison to traditional businesses in Brazil. Distributed

technologies and governance models that have received a lot of attention, such as Distributed Autonomous Organizations and blockchains, could help the country scale up platform co-ops and meet the UN's Sustainable Development Goals. Will they be impactful? Who will be the core supporting organizations of this movement in Brazil? It is still too early to tell. What is clear is that policymakers can help this sector grow by creating an enabling environment through procurement, technical assistance, startup funding, as well as the removal of entry barriers and the enactment of regulations that level the playing field between platform cooperatives and traditional tech companies. In short, by supporting platform cooperatives, policymakers can contribute to a more equitable and sustainable digital economy.

Recent estimates indicate that there are 1.5 million drivers and couriers in Brazil who work via digital platforms. While this represents a small fraction of the country's overall workforce, it is a rapidly growing trend that is having a significant impact on the Brazilian economy.

What if those couriers could own their own company? This is the premise behind platform coops, which are businesses that primarily sell goods or services digitally and run platforms through democratic decision- making and shared ownership. Platform co-ops are a viable alternative to the current digital economy challenges. They represent concrete pathways for novel ownership models, possible solutions to reduce inequality in the gig economy, and proposals to democratize the Internet.

If we are to build a fair and just society, we must review how data is processed in the digital

economy. In Latin America, we have the opportunity to build an innovative and assertive cooperative digital economy. But what are the institutions, policies, businesses, and technologies that promote cooperative infrastructure in Latin America?

Over the last eight years, people from all walks of life have come together under the banner of "platform cooperatives" to experiment with alternative platform economies. From doctors to farmers, professional home cleaners to taxi drivers to artists, these collective efforts have been launched in more than 60 countries.

They are the messengers, social media influencers, and content creators who are using their skills and creativity to hack the system and create change. It's about the fight for a more democratic internet and decent work in the platform economy. They are the feminists who are reimagining the digital world as a place where they can run and own their own businesses and build a regenerative commons. They are building a new internet—one that is rooted in care, autonomy, and healing. They are creating online spaces that center marginalized voices and focus on collective liberation. Places where they can be their whole selves—places for livelihoods, love, and dignity. They are reimagining the digital world as a place that they run and own themselves. In this new Internet, they are claiming their power and creating the future they want to see. And you can too.

From The Drivers Cooperative in New York City to Coomappa in Araraquara and Señoritas in São Paulo, platform coops co-shape spaces of people on the frontlines of making this imagination a reality.

The New School's Platform Cooperativism Consortium, or PCC, has been at the forefront of these efforts since the beginning. From policy analysis conducted by our research institute to the establishment of solidarity networks by the Platform Cooperativism Consortium to support emerging efforts in this sector, we contribute to this struggle in a variety of ways. The PCC is now a hub that helps these groups get started, grow, or convert. Sister organizations have been established in Germany, France, Indonesia, and other countries. Through its fellowship program, PCC's research arm, the Institute for the Cooperative Digital Economy, ICDE, is dedicated to the study of the cooperative digital economy. Once a year, people who are dedicated to changing the way the digital economy operates assemble for the PCC conference. Past gatherings have taken place in New York City, Hong Kong, and Berlin. PCC has partnered with a number of organizations to collaborate and expand this work: including with the Berkman Center at Harvard University to explore data collectives, blockchain, and data trusts; with Mondragon Corporation for popular education on the digital economy and platform cooperatives; with the USC/Berggruen Institute to publish a white paper on policies for platform cooperatives; among others. Recently, PCC and the Institute for Technology and Society of Rio de Janeiro developed the course "Crypto, DAOs and Coops," with wide reach in Brazil. PCC's partnerships enable it to draw on a broad range of expertise and experience in order to achieve its goal of promoting the growth of the digital cooperative sector.

This year, PCC is partnering with the Institute for Technology and Society of Rio de Janeiro (ITS) to bring the PCC conference to Brazil, Latin America and beyond. ITS is an independent, nonprofit organization whose mission is to ensure that Brazil and the Global South respond creatively and appropriately to the opportunities afforded by technology in the digital age, and that the potential benefits of these opportunities are widely distributed throughout society. In addition to publishing analyses, hosting events, and offering courses, ITS has been at the forefront of discussions pertaining to technology and its effects on society. A forum on platform cooperativism and public policy held in Porto Alegre in June 2022 resulted in the creation of an action plan for platform cooperativism in Brazil with the aim of establishing an ecosystem of work, technologies, and local development. Inspired by the publication of Cooperativismo de Plataforma back in 2017, much important work has been done in Brazil over the past years.

The recent public release of a manifesto examining the public policies that will enable platform cooperativism in Brazil has ramped up the collection of signatures from social movement supporters, cooperative leaders, public figures, and policymakers.

This conference has various underlying themes:

- The ability of cooperative principles to strengthen worker wellbeing and reduce power asymmetries in the digital economy;
- Co-ops face numerous significant obstacles, including those related to access to capital,

business development assistance, enabling legislation and policy, and the creation of pan-national federations that share digital infrastructure;

- The governance mechanisms required to ensure maximum stakeholder participation and voice, such as democratic procedures to improve service agreements, algorithm design, and climate impact reduction;
- The solutions needed to scale-up resiliency, racial and gender equity, work empowerment and work satisfaction in the existing co-ops' ecosystem;
- Identifying existing networks and needs, before outlining solutions;
- The imagination for a new generation of shared-services co-operatives for self-employed workers, who utilize digital infrastructure to provide tailored services to dispersed members.
- Building awareness of the co-op option at key themes, including data collectives versus data colonialism, crowdfunding- approach versus venture capital investments, cooperation versus competition, distributed versus centralized governance.
- Practical, hands-on work of global sector coordination in order to avoid reinventing the wheel and instead form federations and share digital infrastructure globally—the kind of work that goes beyond representation and analysis.

While most conferences follow the academic playbook, we are taking it a step further by bringing

together not only academics and researchers, but also workers, organizers, artists, entrepreneurs, policymakers, and social movements in a variety of formats. The purpose of this conference is to establish alternative solutions for the digital economy, not merely to encourage incumbents to behave more ethically. Building on long histories of worker struggles and working alongside allies in many social movements, we aim to create entirely new systems that work for everyone. As a gathering focusing on Brazil and Latin America, this event weaves together the region's various efforts to build a fairer and more democratic internet. With this future in mind, we invite you to the Museum of Tomorrow in Rio de Janeiro to kickstart your own digital future.

Briefings from Workers

Elite organizations will not solve the problems of the global majority. Communities don't need to be told what they need or want; they already know. Workers who team up with social movements will effect social change by abolishing exploitative systems and establishing a new world that is just and equitable for all. In these Worker Briefings, we will learn about significant national initiatives to establish a more equitable and democratic digital economy in sectors such as delivery, freelancing, and recycling. Brazil is becoming a fertile environment for platform cooperatives. Welcome to the Workers' Briefings. [portuguese]

Señoritas Courier

Aline Os is the founder of Señoritas Courier, a delivery collective formed by women and LGBTQIAP+ people in São Paulo. What makes Señoritas unique is its horizontal structure and collective decision making. In other words, its members define

how the business is managed. This is in contrast to most delivery services, which tend to be highly centralized and use high-tech platforms that allow little worker participation. For Señoritas, it is important to see the people who make up the collective as holistic beings with needs and desires beyond simply making deliveries. [portuguese]

Jacira Sousa believes that their organization can also help to address other social issues such as access to the city, technology, and health. The relationship between the collective body and technology is paramount, and technology is regarded as essential for the development of the work, with internal actions for the digital inclusion of the collective's people. Señoritas Courier is all about hacking solutions and subverting the logic of profit as a goal, while prioritizing good working relationships and working conditions. [portuguese]

AppJusto

AppJusto is a new delivery app that is taking a fairer approach to the gig economy. Unlike other delivery apps, Justo allows workers to set their own prices for deliveries, and there is no ranking system between workers. As **Pedro Andrade** explains, the app is open source and collectively funded, meaning that it can serve as an inspiration for other cooperatives. Applusto rethinks a food delivery platform as a "collective good" in which the company charges no service fee to couriers. [portuguese]

Hire Those Who Struggle Edson Sousa will introduce "Hire Those Who Struggle," a virtual assistant created by "Movimento dos Trabalhadores sem Teto," the Brazilian Homeless Movement. The assistant connects homeless people looking for work with people who are seeking services such as cleaning or painting. The technology, which is free for the workers, is run through Whatsapp and has been used more than 3,000 times. The personal information of workers is not shared with clients. [portuguese]

Cataki

Cataki is a free platform that connects waste collectors with individuals and organizations who need their residential or commercial waste recycled. In Brazil, over 300,000 people have already downloaded the app. Over 4,500 waste collectors in more than 1,700 cities use the software. The Cataki app additionally supports over 300 recycling cooperatives. Presented at the conference by the founder, **Mundano**, the app is designed to assist the community of waste pickers in increasing their earnings, identifying new partners, and locating the best locations to sell their recyclable materials. Cataki's platform is also used by the non-profit organization "Pimp my Carroça," which is responsible for the creation of Cataki. [portuguese]

Cooperative Fireside Chat with Trebor Scholz, Ronaldo Lemos, Aline Os, and Jacira Sousa

One of the highlights of the first day of the conference features Trebor Scholz and Ronaldo **Lemos** in conversation with Aline Os and Jacira Sousa. Aline and Jacira are members of Señoritas Courier, a collective that seeks to develop a delivery platform owned by women and members of the LGBTQIAP+ community in São Paulo. Jacira explains, "Traditionally, delivery services were owned and operated by cisgender men. Señoritas is changing that by providing job opportunities for queer people." Aline echoes the sentiment, adding that Señoritas is "not only good for the LGBTQIAP+ community, but also

for the companies that hire the services." Thanks to businesses like Señoritas Couriers, the delivery industry is becoming more inclusive. As a communityengaged researcher, writer, professor, and founding director of the Platform Cooperativism Consortium, PCC, at The New School in New York City, Trebor Scholz has been very influential in shaping the cooperative digital economy as a constructive and hopeful response to platform capitalism. He argues that to build a democratic Internet, we must first create a cooperatively owned and operated digital economy as part of a broader solidarity economy toolkit. Ronaldo Lemos is a Brazilian lawyer, law professor, author, co-founder of the Institute of Technology and Society (ITS) of Rio de Janeiro, co-author of Brazil's Internet Law ("Marco Civil") and a member of the World Economic Forum's Global Agenda Council on the Future of the Internet.

This conversation between Scholz, Os, Sousa, and Lemos will set the stage for the conference and provide some concrete ideas on how we can build a cooperative digital economy. Some of the key questions they

will discuss include: What is a platform co-op? What are the principles of the cooperative digital economy? How can we build an ecosystem of cooperatives that can compete with incumbents? [english] & [portuguese]

Fabro Steibel and Rafael Zanatta in Conversation About the Brazilian Context

Location: Auditorium

Rafael Zanatta has provided a detailed chronicle of the development of Brazilian platform cooperativism in his in-depth report, published in Portuguese and English by PCC and ITS Rio de Janeiro. He presents an overview of the collaborative economy and its various models before delving into platform cooperatives in particular. He examines the history of cooperatives in Brazil, as well as key challenges and opportunities in the country.

Zanatta highlights some of the unique characteristics of the Brazilian context that have contributed to the country's strong growth of this movement, both institutionalized and non-institutionalized. He acknowledges the large number of social movements and grassroots organizations active in Brazil, as well as the fact that many workers are already accustomed to working in informal and collaborative structures. In this session, Steibel, a Global Council member of the World Economic Forum and the Executive-Director of ITS Rio, will discuss these recent developments and add the perspective of ITS Rio, one of Brazil's most respected technology research institutes. Steibel discusses the subtleties of the connection between cooperatives and legislative advocacy, as well as the difficulties faced by aspirant grassroots groups seeking to have an impact. As an example of the open government agenda adopted in Brazil, he discusses the current role cooperatives have in influencing political institutions. He then moves on to address the particularities of the country's collective organizations, which create tensions between new and old organizations. [portuguese]

Mary Watson will be joined by Professor Daniela Trejos Vargas, Central Coordinator of Graduation at PUC-Rio. As a private, non-profit, Jesuit university, PUC-Rio has a strong commitment to social engagement and was among the first universities in Brazil to offer and promote entrepreneurship

In his book **Platform Socialism**, **James Muldoon** advocates for democratic control over platforms and supports platform cooperatives as part of a broader sequence of turning points on the path to platform socialism. Trebor Scholz on Platform Cooperativism

Trebor Scholz will talk directly about the challenges faced by platform workers, including fluctuating wages, unpredictable hours, dangerous working conditions, social isolation, and arbitrary management. Scholz is also worried about the subjugation of content moderators and social media influencers due to the lack of non-corporate digital infrastructure. Under the banner of "platform cooperativism," new types of digital businesses have gained popularity in recent years by staying true to cooperative principles and drawing on a long history of worker struggles. Platform coops are bringing more stability, dignity, and autonomy to gig economy workers in 60 countries now, not in the distant future. Scholz will provide an update on the development of the ecosystem, the global network of researchers, policymakers, and practitioners, and the impact of the work of the Platform Cooperativism

Consortium, PCC, its sister organizations, and associated movements. [english]



Rafael Zanatta on Platform Cooperativism in Brazil

Location: Auditorium

Rafael Zanatta will talk about the origins of the platform cooperativism movement in Brazil, as well as the key differences between institutionalized platform cooperativism, which puts the emphasis on open innovation, and non-institutionalized platform cooperativism, which

focuses on social justice and the fight against precarious labor in Brazil. Based on this distinction, he will investigate the possibility of inductive public policies in Brazil, as well as greater collaboration among various organizations in this emerging sector working to create a more democratic, innovative, and equitable platform economy. In recent years, more municipal policymakers have begun to encourage and facilitate the formation of platform cooperatives. The PCC/ITS report by Rafael Zanatta and the PCC/ Berggruen Institute report by Trebor Scholz et al. are two important studies that investigate how municipal policymakers can and do support the expansion of platform cooperatives. The reports illustrate how

municipal policymakers in Brazil and beyond can foster a conducive environment for this movement. In doing so, they can contribute to the creation of decent work, the development of resilient communities, and the advancement of economic democracy in Brazil. [portuguese]

New Strategies for Platform Work in Latin America

Location: Auditorium *Guided by Renata Tomaz*[portuguese]

The **Fairwork Foundation** has been working in Latin America to assist platform economy workers. The gig economy is rapidly expanding in Chile, and international migration is contributing to this expansion. In recent years, Ecuador has seen a surge in platform-based work, but very little of it is fair or dignified. According to the Fairwork Foundation's report on platform work in Ecuador, the government should take steps to ensure that all workers are protected by labor laws. Besides this, in Latin America, there is also a growing movement of workers who want to establish their own platform cooperatives. Speakers advocate for the government to create a favorable regulatory environment for platform cooperatives and to invest in digital literacy programs for workers interested in establishing their own cooperatives.

A Report on the Work of the Fairwork Foundation in Latin America

The Fairwork Foundation is a research and policy organization that focuses on promoting fair work practices in many countries. The foundation was

established in 2015 in response to growing concerns about the proliferation of low-quality jobs and the declining standard of employment rights and protections, especially among platform workers. Since then, the Fairwork Foundation has significantly contributed to research and policy debates on these issues. As the debate about the future of work continues to intensify, the Fairwork Foundation will continue to provide ratings for platform labor platforms, as well as policy recommendations for government and business leaders. Researchers Jonas Valente and Alessio Bertolini will introduce this work. [english]

What Role Does International Migration Play in Chile's Gig Economy?

Chile has seen an increase in international migration in recent years. This has coincided with the growth of the gig economy, which has created new employment opportunities for migrants. However, these jobs are frequently low-paying and precarious, and migrant workers frequently face challenging working conditions. Nonetheless, they have found ways to fight for their rights and resist these

conditions. For example, Riders Unidos Ya in Chile has been organizing against the company Pedidos Ya, which has been accused of exploitation and poor working conditions. These conditions have deteriorated since the pandemic's outbreak, but migrant workers have continued to fight for their rights. This talk by Macarena **Bonhomme** will center on the role of international migration and the gig economy in Chile, as well as how migrants resist exploitation and precarity. [english]

Building Chilean Platform Cooperatives: Why and How

Matías Bertranou In Chile, platform co-ops have the potential to be a powerful force for good. This presentation by Matías Bertranou will focus on the Chilean context for platform co-ops, including the challenges of starting co-ops in an emerging sector. It will also look at the similarities between platform co-ops and traditional cooperatives, as well as how platform co-ops can be used to boost entrepreneurship opportunities in Chile. [english]

Introducing the Data Cooperative: A Novel Approach to Data Pooling and Sharing

Location: Observatory *Guided by Victor Barcellos*[portuguese]

The past year has seen a growing interest in the concept of data cooperatives. A data cooperative is an organization that is owned and controlled by its members, who pool their data in order to create a shared resource. The cooperative then uses this data to provide services to its members. There are a number of advantages to this model, including the fact that it gives members more control over and access to their data, and that it allows for the creation of a virtuous circle in which data is used to improve the quality of the services offered by the cooperative. This session will explore the potential of data

cooperatives, and will discuss some of the challenges that need to be overcome in order to make them a success.

Decentralization of Data: How Countries Are Using Legislation for Control

In recent years, data control has become more localized and decentralized. Concerns about data privacy and security, a desire for more local control over datadriven decision-making, and a desire to foster competition and innovation in the digital economy are driving this movement. Several countries around the world are decentralizing control of data use. California has spearheaded this movement in the United States. The California Data Protection Act of 2018 granted residents new rights to their personal data. The act established the Attorney General's Data Protection Agency to enforce these rights. The 2019 California Consumer Privacy Act gave residents more control over their personal data. Other states and countries have used these laws as a model. ICDE research fellow Katya Abazajian discusses state and local policy that data cooperatives should be

aware of to work at the local level, using California as a case study. [english]

Data Cooperatives: What, Why, and How

Adriane Clomax, a current ICDE research fellow, will give the lay of the land for data cooperatives. She notes that data co-ops, as part of the landscape of platform co-ops, exist and thrive within certain parameters. These are cooperatives that are oriented towards social good, and have a business model in which the members control and access the data that is generated. The advantages of this model are many, including that it allows for more democratic decisionmaking about how the data is captured and used. It gives members a greater stake in the value that is created from their data and creates social and economic value for their communities. [english]

Open Data and Smart Cities

How can open data rely on cooperative governance to strengthen communities and assist cities in meeting upcoming social and economic challenges? How can cooperatives share data and collaborate on technological infrastructure among their members? These are just a few of the topics that **Ana Carolina Benelli** will cover in this panel, which will feature real-world examples of city government, health and agricultural cooperatives, and information technology solutions for using data for social good.[portuguese]

Portable Worker Portfolios for the Gig Economy

Martijn Arets understands the unique challenges that come with the gig economy, especially the lack of portable worker portfolios. That's why he created GigCV, an easy tool for anyone working in or gaining work experience in the gig economy. With this open standard, gig workers can easily download their own reputation and transaction data, which serves as proof of their work experience and skills on connected platforms. GigCV is available to 50,000 workers in the Netherlands. [english]

Introducing Needs Map: Resilience in the Face of Poverty and Disaster

Evren Aydoğan will speak about how the platform co-op Needs Map can help to improve the lives of millions of people throughout the world. Needs Map leverages platform cooperativism as the cornerstone for a new sort of community-based social solidarity to reduce challenges associated with poverty and natural disasters. It uses Geographic Information System technology to analyze and present geographically referenced data in order to help communities and cooperatives/nongovernmental organizations become more resilient. Needs Map integrates fintech, for instance, to support the growth of local/cooperative social marketplaces. This will facilitate the immediate connection of individuals in need with available services and resources. Needs Map ultimately gives an alternative perspective on the relationship between people and technology that can assist us in constructing a more just and equitable world.

Aydoğan's talk will be followed by a lightning presentation by the Director of Innovation at Suara Cooperative (Catalonia's largest worker cooperative), Jordi Picas Vilà who works on developing the technology and tools the cooperative needs to best serve its community of care workers.

Can Coops Solve DAO's Governance Issues?

Location: Auditorium

Guided by Trebor Scholz [english]

As interest in decentralized autonomous organizations (DAOs) grows, it is critical to consider the future challenges they may face. One critical issue

is governance. Cooperatives, conversely, have a long history that can teach us how to overcome these obstacles. Developers can learn how to build more resilient and effective DAOs by studying the successes and failures of cooperatives.

An Introduction to Blockchain and Distributed Autonomous Organizations

Ronnie Paskin is a blockchain expert and well-known name in the IT industry, having spent over three decades as a software engineer. He is also a researcher at Rio de Janeiro's Pontifical Catholic University. For this session, he will introduce us to distributed technologies and Distributed Autonomous Organizations. Ronnie's experience in the blockchain field makes him uniquely qualified to speak on this topic. In addition to his work in the private sector, he has worked with startups both in Brazil and in the USA, and educational institutions with a deep commitment to social issues. As a result, he has a deep understanding of both the technical aspects of distributed systems and the social implications of these technologies. [english]

The Corporate and Labor Governance Concerns of DAOs

Increasing numbers of distributed autonomous organizations, DAOs, have prompted new forms of corporate governance, Morshed **Mannan** argues. DAOs are managed by algorithms that automate various governance tasks rather than by a central board of directors. This tactic fixes some issues with traditional corporate governance, but it also introduces new challenges due to the inherent incompleteness of contracts. This is described as the problem of corporate governance-by-design. This talk serves as a cautionary note to emerging cooperative DAOs by highlighting potential governance issues they may encounter in the future. It also discusses the phenomenon of a growing group of people working through and for DAOs, raising questions about the rights that ought to be granted to them. To gain access to worker rights, it is essential to recognize some DAO members as workers. With respect to these governance concerns, the history of cooperatives, the application of employment law to worker cooperatives, and governance

of worker co-ops offers salutary lessons. [english]

How Developers Can Learn From the History of Cooperatives

Jad Esber is an entrepreneur and product builder who is interested in decentralized technologies and their applications. Esber is also interested in the history of cooperatives and the key takeaways from this history that can be applied to developing new internet platforms and protocols. He argues that cooperatives have been successful in creating alternative models of ownership and control, but they have also faced challenges in terms of scalability. Consequently, he has investigated how developers and emerging internet companies might learn from the shared history of cooperatives and how, in practice, they can construct systems that respect cooperative ideals. *english*]

Bridging the Gap Between Blockchain and the Commons

Particularly in the context of cooperatives, there is a growing interest in decentralized platforms. The rationale

for selecting decentralized platforms over centralized ones is frequently based on the concept of the commons. The commons are communityowned resources, as opposed to those belonging to an individual or corporation. It is believed that blockchain technology is well-suited for managing the commons because it can facilitate the formation of trustless. peer-to-peer relationships. There are already a number of cooperatives utilizing blockchain technology, including Dork. tech. Decentralized autonomous organizations (DAOs) are a type of decentralized platform whose governance capabilities are gaining popularity. DAOs are organized around smart contracts, which are contracts that execute themselves and enforce the organization's rules. Depending on the context, the specific conditions that make DAOs preferable to centralized platforms may include greater transparency, accountability, and control for members. In conclusion, blockchain technology offers cooperatives new opportunities to govern themselves in ways that are more consistent with the values of the commons. Philémon

Poux's research centers on this discussion.

The Brazilian Artists Who Are Helping Themselves

Location: Observatory *Guided by Aman Bardia [english]*

Commons-based approaches are being adopted by cooperatives and other cultural organizations. These strategies are based on the sharing of resources and knowledge for the common good. Commons-based strategies have helped to preserve billions of images, and they may be equally effective in protecting the rights of artists. Platform cooperatives appear to be well-suited to approaches based on commons as they may improve the lives of cultural workers by pooling resources and knowledge.

How You Can Help to Preserve Billions of Photos

In 2022, Flickr Inc. established the

Flickr Foundation to preserve its corpus of billions of images. The Foundation values community ownership of these photographs and seeks to preserve them for the next 100 years. They plan to do so in part by educating the general public on how to protect art and culture by emphasizing the importance of the preservation of recent digital histories. To that end, the Flickr Foundation will apply Commons theory to propose policies that prepare this vast collection more deliberately for the future public domain, and prevent unauthorized use of images stored on its site. ICDE fellow **George Oates** is presenting this important work. [english]

Equity for Brazilian Artists: A Critical Study of Platform Coops

Brazil has a rich cultural heritage and an abundance of creativity, but it also has significant levels of inequality, making it difficult for artists to find affordable studio space and make a living from their art. **Victor Barcellos** ICDE fellowship report investigates how platform cooperatives improve working conditions for artists in the country. They can,

for instance, serve as online marketplaces for artists, granting them greater autonomy and control as well as more equitable compensation. By recognizing art as a public good, such platform cooperatives can also help to make art accessible to all. In this way, platform coops and the free culture movement can work together to help sustain the Brazilian arts community. [portuguese]

The Power of Commons-Based Strategies for Cooperatives in the Global South

What are the possible connections between commons and cooperatives? Drawing from his research on commons theories and practices, Miquel Said Vieira argues that cooperatives can become more impactful and inclusive by understanding and employing commons-based strategies, particularly in the Global South. A commons-based approach would provide them with access to a wealth of resources and knowledge, as well as the ability to engage in collective action. Finally, Vieira argues that theories of the commons can inspire new

models for cooperative decisionmaking that are more responsive to the needs of members. [portuguese]

Can Free Culture Save the Day for Platform Coops in

the Cultural Sector?

In recent years, resistance to the commodification of culture has picked up steam. **Leonardo Foletto** is one of the most prominent figures in this movement, also known as the free culture movement. In his new book, *Culture Is Free: A* History of Anti-property Resistance, for which Gilberto Gil wrote the introduction, he discusses the role Creative Commons can play in the free culture movement. Creative Commons is a nonprofit organization that offers a set of copyright licenses that enable creators to share their work without relinquishing all of their rights. This can be a useful tool for creators who wish to make their work accessible to the public while retaining control over its usage. Finally, Foletto ponders how the free culture movement

New Job Creation Strategies in Brazil

Location: Auditorium *Guided by Luciana Bruno*[portuguese]

A new public policy is creating jobs and reducing poverty in Araraquara, Brazil. The city has assisted in the establishment of two platform cooperatives, which address the low wages and precarious work of the gig economy, particularly during the pandemic. The success of Araraquara shows that supportive policies can effectively encourage these businesses to exist.

From Araraquara, Brazil: A Model for Public Policies in the Creation of Platform Cooperatives

Need a Ride? Check Out Brazil's Newest Driver Cooperative! The Coopera Araraquara government program is a public policy that aims to encourage the creation, development, consolidation, sustainability and expansion of cooperatives and other associative groups, through a public solidarity business incubator. Vivian Pacheco, as the program manager, is supporting the creation of a driver's cooperative (Morada Car) and a food distribution cooperative (Morada Express) in the city of Araraquara in the state of São Paulo. The local government sees the solidarity economy as

an important way for social and economic development. By hiring cooperatives, the city is also able to help improve its public-service offerings. [portuguese]

A New Way of Creating Jobs in Brazil

The labor ministry in Brazil is an important part of the country's legal system. The ministry is responsible for enforcing labor laws and protecting workers' rights. As public prosecutor, **Renan Kalil** is a vocal supporter of workers' rights and has advocated for better working conditions and stronger antiexploitation safeguards. He has also criticized the impact of the pandemic on Brazilian workers, particularly those in the informal sector. Kalil has recently advocated for the expansion of platform cooperatives as a means of creating more secure and sustainable jobs, thereby improving the lives of Brazilian workers while also reducing poverty. [portuguese]

Platform Cooperatives within Platform Regulation Alexandre Costa Barbosa, a specialist advisor for the Brazilian

Internet Steering Committee, will

present the scope of platform regulation being discussed in Brazil, considering the typology of platforms and the extent to which platform cooperatives could be strengthened. He will discuss platform competition, as well as the limits of platform cooperatives. Understanding the various types of platform coops allows us to create better policies to support them. Furthermore, by understanding platform competition, we can learn how to level the playing field so that cooperatives can thrive. Finally, he will introduce the multisectoral aspect of Internet Governance and the leading role of Brazil with this regard, bringing reflections for platform cooperatives governance. [portuguese]

From India, and Italy, to the U.S. Senate: What Policy Can Do to Unleash the Power of Digital Cooperatives

Location: Observatory *Guided by Eneida Santos [english]*

What began as a niche created by a few tech-savvy individuals has grown into a global movement with supporters in nearly every country. With a number of initiatives underway, it appears that the Indian state of Kerala is now leading the way in digital cooperative development. For decades, Italy's cooperatives have assisted people in breaking the cycle of poverty. Cooperatives are supported and promoted by senators from both parties in the United States. This forum will provide global perspectives on policy initiatives in this sector.

Indian State Leads the Way

Mohit Dave has focused on the growth of platform cooperatives in South India, particularly looking at Kerala through organizations like the Kerala Development and Innovation Strategy Council, a strategic think-tank and advisory body established by the Government of Kerala. As a researcher for the International Cooperative Alliance, he studies the landscape of (platform) cooperatives in the Asia-Pacific region. Mohit has also conducted research on the impact of cooperatives on SDGs, their resilience in the COVID-19 pandemic and their relevance

in the Social and Solidarity Economy. He is involved in several initiatives to build a network of influencers and institutions invested in platform cooperatives to engage them meaningfully. [english]

It's Time to Convince the U.S. Senate

Sadev Parikh, a current ICDE fellow, is on a mission to make platform co-ops more palatable to Senators in the United States. In a recent article, he outlines four levers that could be used to incentivize the growth of these businesses: anti-trust legislation, interoperability, privacy legislation, and support from the Small Business Administration (SBA). The SBA is a federal government agency that provides loans and other assistance to small businesses. Getting state and local governments to implement policies that encourage employee ownership could be one way to ensure that the SBA is supporting co-ops. For example, the City of Pittsburgh has created a task force on employee ownership that is working to promote this model of business. Senators who are supportive of small businesses

and promoting competition may be particularly receptive to these ideas. By using these levers, we can create an environment that is more conducive to the growth of platform co-ops.

A Report From Bologna, Milano, and Biella

Pietro Ghirlanda is an Italian academic who focuses on the role of platform cooperatives in the Italian context. He has conducted case studies in three Italian cities: Bologna, Milano, and Biella. In each of these three cities, he has studied how municipalities support platform cooperatives and social and solidarity platforms by assessing history, value proposition, organizational form, competitive advantages, paradigmatic elements and interviewing the most important stakeholders involved in three emblematic examples: Vicoo Platform, So.De and Welfare X. Ghirlanda adopts an ecosystemoriented and institutionalist perspective, referencing also to the commons literature. [english]

Rafael Grohmann: Worker-Owned Platforms: Learning, Theorizing and Policy Making from Latin America

Location: Auditorium

This talk by one of the most active academic proponents of platform cooperativism, Rafael **Grohmann**, will focus on the theoretical and public policy possibilities of building platform cooperativism in Latin America. Thus, the presentation will have four sections: 1) The concept of worker-owned platforms and its place in the discussion on platform labor and platform cooperativism, in relation to the global circulation of worker struggles; 2) Theorization on platform cooperativism from Latin America, taking into account historical learnings from the region in relation to the development of technologies and work organization, and also from authors such as Jesús Martín-Barbero, Álvaro Vieira Pinto, and the current debates on Big Data & AI from the South. This means that platform cooperativism from the South cannot just be a "tropicalization" of the concept,

but an effort at theorizing from below; 3) Based on these lessons learned, an invitation to imagine prefigurative possibilities of worker-owned technologies and their relationship with a wider circuit of production and consumption, connecting past, present and future; 4) Draft of a public policy agenda for workerowned platforms in dialogue with workers, governments and policymakers.

Rafael Grohmann's talk on platform cooperativism in Latin America will undoubtedly inspire the advancement of platform coops in the region. Grohmann is making the case for a platform coop movement that is specifically geared toward the needs of people in Brazil, taking into account the country's distinct cultural and economic context and correctly rejecting a "helicoptering in" of organizational structures from the Global North. Rosana Pinheiro-Machado Reveals How The Far-Right is Mobilising Platform Workers

Location: Auditorium

One of the most significant drivers of the growth of the far right is the use of digital platforms to spread extremist ideologies. **Rosana Pinheiro-**

Machado, an expert on the far right, explains how these platforms are being used to reach new audiences and recruit members. "There's a very active network of far-right YouTubers and Facebook pages that are pumping out content that's giving people a very distorted view of the world," she said. "And it's not just information about politics or immigration; it's also conspiracy theories and fake news." This content is often amplified by algorithms that favor engagement over accuracy, creating a feedback loop that drives further growth of the far right. While there are many factors contributing to the rise of the far right, Pinheiro-Machado believes that the use of digital platforms is one of the most important. Could alternative models of social media counter these developments?

Sain López, co-founder of the Mondragon Team Academy, studies the Basque platform coop ecosystem. Platform Coops Now! is presented by Aitor

Lizarza Martin. Natxo Devicente of Mundukide promotes cooperatives in the Global South through cooperatives. Raul Amorim, a leader of the Brazilian Landless Movement, believes that platform cooperatives can help them sell their products through non-traditional channels.

Nurturing the Growth of a Basque Digital Cooperative Ecosystem

Sain López, co-founder of Mondragon Team Academy, will analyze how the platform co-op ecosystem can be established and supported by the Basque government, as well as the Mondragon, a network of consumer and worker coops in that region. She will also discuss case studies of some viable platform cooperatives in this region. Sain believes that lessons from the widely known cooperative tradition of the Basque country can be applied to the creation of successful platform cooperatives. She will outline how the Basque government can support these types of businesses and how cooperatives can team up to build a flourishing ecosystem. By considering these achievements,

and relatedly, new municipalism, we can learn how to foster more conducive environments for platform cooperatives worldwide. [english]

Their vision is to build a more just and equitable world in which collaboration, rather than competition, drives innovation.
